HENRY VANMETER TIMELINE – 2023

EARLY LIFE – I get really confused trying to figure out if any of the earlier documents in various counties and states apply to my ancestor Henry VanMetre who married Martha Moore of Cumberland & Jefferson Twp., Greene Co PA. There are multiple suggestions for parentage. There are multiple Henry Vanmeters, and facts about our ancestor are claimed by many others. Abraham Teagarden had land in Hampshire Co VA (WV) in the 1760s that was surveyed by David Vance – Teagarden being the original landowner who brought settlers to the Tenmile region – and Henry Vanmeter also had land surveyed by Vance in the 1760s on Mill Creek on the South Branch of the Potomac on the manor line of Wappocomo (Romney WV) (Hampshire Co VA Deeds, v. 1, p. 81-82; v. 2, p. 139; v. 22, p. 97; also several Northern Neck grants viewable on the Library of Virginia website) - no wife named. Some of the writers that seem to be the most authoritative almost ignore our Henry Vanmeter of Cumberland/Jefferson. Early researchers made wrong interpretations, particularly on the Henry with the three wives, that have been repeated on every website. I'm not ready to guess which Henry is ours in the 1760s prior to settlement in the Tenmile country, and I'm not ready to state the names of his parents. The Vanmeters were large landowners, active in court records, and there should be much evidence out there to straighten it all out. However, the family repeats the same names in every generation, and the multitude of literature in print and virtual format serves to cloud things a bit. This timeline serves to place our Henry Van Matre on the map.

HENRY VAN MATRE (died 1803) – WIFE MARTHA MOORE – CUMBERLAND TOWNSHIP

1770s – Waychoff, Andrew J., Local History of Greene County and Southwestern Pennsylvania (Waynesburg, PA: Greene County Historical Society, 1975), No. 113 [Excerpts]. "Early Settlers. The Swans, Vanmeters, Hughes, etc. The fifty emigrants whom I left Camping along the lower Ten Mile valley in No. 37, aided one another in cutting roads to the selections made the previous year and to make new locations. They all scattered to the southward, as was their intention. Van Meter Tomahawks Claim. Henry Van Meter tomahawked a large claim to what is known as the Randolph and Price settlement, two and one-half miles southeast of Jefferson. The first cabin stood near the excellent spring at the home of the Prices..... No trouble was given these settlers by the Indians until 1774, the time of Dunmore's war. This was the place of the Swan-Van Meter fort as stated elsewhere..... Many Thrilling Adventures. Many were the experiences of the Swan and Van Meters. The story of most of them has been lost. Here is one yet told. A young girl, a niece of the Van Meters, was stolen by Indians and taken away and escaped after being taken many miles from home. She wandered many days in her attempt to return home. Her food was mostly only roots and wild berries. She suffered much from hunger and exposure. She found a dead snake and ate it with relish, and in later life said it was the best meat she ever tasted. After many days she found her way home.... Richard Hughes married a Van Meter and built his cabin at the site of the old Alfree Mill and later built a mill there, which site later fell into the ownership of the Alfrees.... It was Henry and not Jacob Vanmeter who immigrated to this county in company with John Swan and Thomas Hughes. This is the fact, not withstanding, "Border Warfare" records it as Jacob. However, there seems to have been another family of Vanmeters in the county at a very early day, as a record of membership in the Goshen Baptist Church at Garard's Fort embraces among its first members Jacob, John and Abraham Vanmeter and their wives and Benjamin Vanmeter. A Baptist history in my possession also speaks of Jacob Vanmeter as of the Muddy Creek settlement. But the descendants of the Swans and Vanmeters, who have every facility of knowing, assert that it was Henry who came with Swan and Hughes as stated above. He was a public spirited and very popular man. He is said to have had the first commission for justice of the peace ever held in the territory of Greene county. His first appointment was from the governor of the colony of Virginia. He was elected a justice

of the peace for Cumberland township, Washington county, in the year 1782, and was elected one of the commissioners of the county in 1788. First Baptist Church in County. He was a staunch Baptist, and joining a few others built a Baptist meeting house on the farm now owned by Ellis B. Bailey. It was used for many years as a place of worship. It was the first Baptist church erected in this county and was the only one ever built in the vicinity of Carmichaels, and I am told that relics of its ruins are still visible on its original site. Henry Vanmeter had three sons, Rezin, Craven, and Abraham [actually grandchldren], who emigrated to Ohio at an early date. His son Jesse married Nancy Seals, of the Jackson Fort settlement, of which marriage William Kincaid, of Jefferson township, is the only living descendant. Jesse lived until the day of his death on a part of the land taken up by his father. The daughters, Elizabeth and Phoebe, married brothers – William and Ellis Thomas. Phoebe, who married Ellis Thomas, moved out to Grave Creek. Elizabeth and her husband settled on the waters of Dunkard creek a short distance above Blacksville, and he was afterwards shot by the Indians."

1773 – Assessment Roll, Springhill Twp., Bedford Co PA, includes Henry Vanmeter and Abraham Vanmeter. [Leckey, p. 126-129 who credits Veach's *Monongahela of Old*].

1773 – Westmoreland Co PA Quarter Sessions, 2nd Term held July 6, 1773 – Two bills of indictment for Riot, found against Henry Vanmetre, Abraham Vanmetre, Jacob Vanmetre, Simeon Moore, Jesse Pigman, Nathan Freaks, Thomas Roach, Daniel Murdoch, Charles Swan, John Swan, John Swan Jr., Thomas Swan, Thomas Hughes, James Johnson, and one Harrison [Crumrine, Boyd. History of Washington Co PA. Philadelphia, PA: H.L. Everts & Co., 1882, p. 152). Springhill Township was included in the newly formed Westmoreland County in 1773 and included what is now Greene, Washington, and part of Fayette County. These Quarter Sessions records do not appear to be online, so I have not viewed the entry, but other historians suggest that this had something to do with the PA/VA border dispute, the Vanmeters and their neighbors being proponents of Virginia.

1774 – Draper Manuscripts, Series NN, Vol. 4, p. 11 (and reverse) (FHL 889179), "A List of Cattle that was Bought and aprised [sic] for the youse [sic] of the Army by William Harrod," including Aug. 22, of Henry Vanmeter, seven steers aprisd. to 25.17.6" – [seems to be the source of the public service claim immediately below]. Reverse is labeled as Capt. William Harrod's account.

1774 – Draper Manuscripts, Series NN, Vol. 4, p. 10 (and reverse) (FHL 889179) – "Henry Vanmetr [sic] 17" on list dated Augt. 22, 1774, under heading "Calves" – probably the original note pertaining to the above.

1774 – Fort Swan and Van Meter – "Cumberland township was probably the first settled township in Greene county. John Swan, as early as 1767, looked upon the stately forest that encumbered all the valley of Pumpkin with an eye of satisfaction, and to notice that he had chosen this location for himself proceeded to put his mark upon it by blazing the trees around a goodly circuit. In 1768-69 he returned and made a fixed habitation. He was accompanied by Thomas Hughes and Jesse Vanmeter, who united their strength for mutual protection. These early pioneers determined to provide for the safety of their families, and accordingly built a strong stockade, which has ever since been known as old Fort Swan and Vanmeter. It was situated near the border of Cumberland township (near the present town of Carmicheals), on the spot where the house of Andrew J. Young stands and was a noted rallying point in its day for the venturesome pioneers and their families. The fort was erected early, not later than 1774, and probably earlier. Until the massacre by Logan and his band, in 1774, there was no trouble with the Indians; though for safety it had become necessary to have a place of refuge and a fort was built on John Swan's farm known as Swan and Vanmeter's Fort." Reference: Report of the Commission to Locate the

Site of the Frontier Forts of Pennsylvania, Vol. 2, Clarence M. Busch, State Printer of Pennsylvania, 1896, p. 436-485. [These forts are often referred to as Fort John Swan and Fort Henry Vanmeter].

1775 – Court for Augusta County (VA), Feb. 23d, 1775 – "Ordered that ... Henry Vanmetre [and others] ... are humbly recommended to his Excellency, the Governor, are proper persons to be added to the Commission of the Peace for this County." [Minute Book of the Virginia Court held at Fort Dunmore (Pittsburgh) for the District of West Augusta, 1775-1776, p. 13 [Boyd Crumrine, *Carnegie Museum Annals*, Vol. 1, p. 533 (1902)].

1775 – Public Service Claims, West Augusta Co VA, Monday, 18 Sep 1775 (Ancestry.com database) – To Hen: Vanmater for 7 bullocks, L 25.17.6, William Harrod's District. (Jacob Vanmater, Danl. Murdock, Felix Hughes, Philemon Hughes, Thos. Gist, Thos. Hughes, and Abm. Vanmater on same page). The book, *Lord Dunmore's Little War of 1774*, by Warren Skidmore and Donna Kaminsky, Heritage Books, Inc., 2002, p. 58, 61, gives more details: To Abraham Vanmeter for 75 ditto [rations & horse hire]; To Jacob Vanmeter [for] 186# bacon; To Henry Vanmeter for 7 bullocks. [A bullock is a steer – young bull.]


1776 – Court for Augusta County, April 18th, 1776 – "On the Petition of James Mitchell & others setting forth that a Road is Established from Conrad Walters, by Wm. Teagarden's ferry, to the Mouth of the Wheeling, which is very Inconvenient to your Petrs [petitioners] & praying that a Review of the sd Road be made. It is ordered that Ebenezer Zane, James McMahon, David Owens, Henry Vanmatre, Dav'd. Evans, Geo. Cox, James McCoy, John McClalan, or any 6 of them, being first Sworn, view if the old Road Estab [established] is Conv [convenient], if not make a report of the most Conv way..." [Minute Book of the Virginia Court held at Fort Dunmore (Pittsburgh) for the District of West Augusta, 1775-1776, p. 76 [Boyd Crumrine, *Carnegie Museum Annals*, Vol. 1, p. 564 (1902)].

1776 – "At a court held at Pittsburgh, for the District of West Augusta, the Twentieth day of August, 1776," Henry Vanmetree [sic] [and others] "are recommended as proper persons to be added to the Commission of the Peace." [Minute Book of the Virginia Court held at Fort Dunmore (Pittsburgh) for the District of West Augusta, 1775-1776, p. 78 [Boyd Crumrine, *Carnegie Museum Annals*, Vol. 1, p. 565-566 (1902)].

1776 – "At a Court Continued and held at Augusta Town [Washington PA] for the district of West Augusta, September the 18th, 1776" Henry Vanmetre [and others] "are recommended as Proper persons to be added to the Commission." [Minute Book of the Virginia Court held at Fort Dunmore (Pittsburgh) for the District of West Augusta, 1775-1776, p. 79 [Boyd Crumrine, *Carnegie Museum Annals*, Vol. 1, p. 566-567 (1902)].


1776-1790 – Henry Vanmatre is mentioned on several slips in the estate record of my ancestor, Barnet O'Neal, who died in 1778. They were in the same military unit but had no familial tie at that time, to my knowledge. Vanmatre was probably acting in his capacity as a Justice of the Peace in Cumberland Township, Augusta Co VA (1754 for this region) – then District of West Augusta VA (1774) – then Monongalia Co VA (1776) – then Washington Co PA (1781) – then Greene Co PA (1796), as state boundaries changed and new counties were formed). May 6, 1776, Barney O'Neal, debit to Thomas Pribble, for old ax, pan handle, gun barrel, and 20 shillings Virginia money, sworn before Henry Vanmatre. May 6, 1776, Barney O'Neel, debit to Reubin Pribble, to 5 lbs of iron, sworn before me, Henry Vanmatre. June 15, 1777, Estate of Barnet O'Nail, deceased, to two bushels and a half of Indian corn, John Swan stated on oath that he had not been paid, sworn before me this 2d day of March 1780, Henry Vanmatre. May 1779, Barnet O'Neel, deceased, debit to Isaac Pritchard, for 18 lbs iron lent to him, 2

gallons whiskey lent to him, sworn before me, Henry Vanmatre. 17 Aug 1779, Monongalia Co VA, then came Torrance Clark before me, one of the justices of the peace for sd county, and made oath against Barnet O'Neel, deceased, to one square bar of English steel 11 inches long, and a small bar of iron, and that Jesse Pigman has got part of old bar, sworn before Henry Vanmetre. 4 Nov 1779, The estate of Barnet O'Nail, deceased, to Daniel Mordock to making 380 shingle nails, sworn before me, Henry Vanmatre. 12 Jul 1790 [year estate was settled], estate of Barnet O'Nail, debit to Josiah Crawford, to one horse, Washington County, before me, Henry Vanmatre. These notes give nice clear signatures for Henry Vanmatre.

1777 – Draper Manuscripts, Series NN, Vol. 4, p 56 (FHL 889179), "Complaint was laid in before me by Capt. Henry Enoch & Henry Vanmator that Capt. William Harod [sic] Hath from time to time embezzeled the Commonwealth Store (ammunition & Booff tea). Know and therefore tomorrow you, the said William Harod to attend, at the House of Theophilus Philips, the second Monday of July next, to answer to the above charge. Given under my hand this 2nd day of June 1777. Zackd. Morgan.





1777 – Henry Van Meter gave an Oath of Allegiance to Charles Swan on 16 Sep 1777. Reference: Waychoff, Andrew J., *Local History of Greene County and Southwestern Pennsylvania*, Column #115.

1778 – Draper Manuscripts, Series NN, Vol. 3, p. 119 (FHL 889179), "May 12th, '78, Gen. H. writes Wm. Minor, Jesse Pigman & Henry Vanmetre regretting that he cannot send them relief & protection (up Monongahela river). Note: This is in Draper's handwriting.

1781 – Effective Supply Tax, Cumberland Twp., Washington Co PA – Henry Vanmatre with 200 acres, 4 horses, 11 cows, 15 sheep; Joseph Vanmatre with 200 acres, 4 horses, 4 cows, 1 sheep; Absolom

Vanmeter [sic], single man, 1 horse. Persons exonerated from paying sales tax, Cumberland Twp., includes Henry Vanmetre, Joseph Vanmetre, and Jesse Vanmetre. And Absolom Vanmetre, single man.



1781 – Draper Manuscripts, Series NN, Vol. 6, p. 28-32, Recollections of Henry Jolly, Esq., Indian Warfare from 1774, being notes to the Ohio Border Warfare, printed at Clarksburg in 1831 – "Some time in May in the year 1781, a large party of hostile Indians, came to the Moravian town on big Muskingum, and encamped round the town for the purpose of preventing the Moravians [illegible] crossing into the [illegible] to the frontier settlements, but a [illegible] was permitted to pass out and conveyed the [illegible] to Fort McIntosh from & thence to Pittsburgh to Col. Brodhead, Commandant of the western department, & from him to the different leading officers on the frontier. Volunteers immediately turned out to the frontier forts, about 12 of us went from the vicinity of Washn. Pa., and went to Vanmater's fort. We arrived there in the waning, and on that day, a small party of natives came in & killed 3 or 4 hogs that Majr. McCollock had in pen on his farm, took two or three horses, & crossed the Ohio above Wheeling, and were joined by the small party from Washington, of which I was in the [illegible] the danger was over for that time, and to our [illegible], but the next day, we read intelligence that a large party of Indians had cross the river at Bogg's Island, 3 or 4 miles below the mouth of Wheeling. [Note: I have included only the paragraphs surrounding the mention of Fort Vanmeter here. This is one of the incidents that led to the raid into Ohio by Col. Williamson.]

1782 – Petition No. 8, from Sundry Inhabitants of Yohogania and Monongalia to be Laid before Assembly, 1782, in The Virginia Genealogist, 17:3, Jul-Sep 1973, p. 214, in opposition to Pennsylvania's claim of their Virginia lands, includes signatures of Absalom Vanmatre, Henry Vanmatre, Jesse Vanmatre, and Joseph Vanmatre.

1782 – Effective Supply Tax, Cumberland Twp., Washington Co PA, includes Henry Vanmatre, 200 acres, 4 horses, 11 cows, 15 sheep; Joseph Vanmatre, 200 acres, 4 horses, 4 cows, 9 sheep; Jesse Vanmatre, 200 acres, 2 horses, 4 cows; single men, Absolom Vanmetre, 1 horse. Persons exonerated from paying sales tax includes Henry Vanmater [sic], Joseph Vanmater, and single man, Absolom Vanmetre.

1783 – Virginia State Archives, No. 25053, Auditor's Account Book, 1783, Auditor's Account XV (15), p. 595 – Richmond, Virga., 24 Oct 1783, Militia, wart. To Henry Vanmeter, for his services in the militia in 1781, 2.6.0.



1783 – Petition from Inhabitants of the West Side of the Laurel Hill Mountains to the President of Congress [to form a new state of Westylvania], January, 1783. Papers of the Continental Congress, Item 48, p. 251-256. Signers include Henry Vanmeter, Joseph Vanmeter, and Abraham Vanmeter. I have a photocopy from Papers of Continental Congress 1774-1789, Series M247 Roll 62, Item 48, Memorials of People in Illinois, Kaskaskia, and Kentucky, 1780-1789, p. 251-253, which seems to be the very same Jan 1783 document. The pages of names are in the same order, except that it reads: Henry Vanmeter, Joseph Vanmeter, Jesse Vanmeter, and Absalom Vanmeter. The first transcription was from a book, *Two Lists of Early Residents in Southwestern Pennsylvania*, by Helen L. Harriss, 1984, and doesn't seem to be as accurate. Note: Henry Vanmeter and Jesse Vanmeter appear on the list twice.

1783 – Assessment for Cumberland Twp., Washington Co PA – No Vanmeters in either the supply tax or exoneration side.

1784 – Assessment Roll for 1784, Cumberland Twp., Washington Co PA – Henry Vanmeter, Jesse Vanmeter, and Joseph Vanmeter refuse to give in their property but must pay taxes [Leckey, p. 133].


1785 – Colonial Records of Pennsylvania, Vol. 14, p. 357: Supreme Executive Council, Philadelphia, PA, Friday, February 11, 1785, "Henry Vanmetre, Esquire, was elected a Justice of the Peace and Court of Common Pleas for the county of Washington, and district of Cumberland, agreeably to a return made according to law." Boyd Crumrine in his *History of Washington Co PA* (1882), p. 249, notes that Hon. Henry Vanmetre was commissioned as an Associate Judge of Washington Co on 11 Feb 1785.

1785 – Assessment Roll for 1785, Cumberland Twp., Washington Co PA – Henry Vanmetre with 200 acres, 4 horses, 11 cows; Joseph Vanmetre with 200 acres, 4 horses, 4 cows; Jesse Vanmetre with 200 acres, 2 horses, 4 cows; and Absolom Vanmetre, single free man.

1786 – Draper Manuscripts, Series NN, Vol. 4, p. 82 (and reverse) (FHL 889179) – April 8th, 1786 – Then received of William Harrod, one pound, one shilling, and two pence, in full for his State and County tax for the year 1785. Henry Vanmeter in behalf of Keanor Seton."


1786 – Assessment Roll for Cumberland Twp., Washington Co PA – Henry Vanmetre, Esqr., with 220 acres, 5 horses, 11 cows; Jesse Vanmetre with 200 acres, 2 horses, 3 cows; Joseph Vanmetre with 220 acres, 4 horses, 3 cows; and Absolom Vanmeter, single free man, 1 horse. Duplicate of state sales tax, includes Joseph Vanmeter, Henry Vanmetre, Esqr., and Jesse Vanmetre; with Absolom Vanmetre, single man.

1786/87 – Cumberland Twp., Washington Co PA Tax List for 1786/87, includes Henry Vanmetre, Esq., paying 126 state tax and 83 county tax.



1787 – Patent, Henry Vanmeter, 393 acres and allowances, called Mergilinia – "Beginning at a WO (white oak), thence by land of Richd Swan, South ten degrees West one hundred forty nine perches to a WO (white oak). Thence by land of James Carmichaels South forty four West forty two perches to WO (white oak). Tehnce by same & Land of Michael Jones. South thirty degrees West fifty nine perches to WO (white oak). Tehnce by Wm. Davis's Land North seventy West sixty perches to Post. Thence North sixty three West one hundred perches to WO (white oak) & North eighty four West seventy one perches to Post. Thence by Land of Joseph Vanmeter North twenty degrees East one hundred five perches to post. Thence by land of Daniel Mordock, and South sixty three East seventy two perches to WO (white oak). South forty four East thirty six perches to hickory. Thence by Land of Median Garwood. South ten West nineteen perches to WO (white oak) & South sixty three East one hundred twenty perches to the place of the Begn Containing three hundred ninety three Acres and allowances of 6 percent for Roads. With the appurtenances which sd Tract was Surveyed in pursuance of a Warrant granted to The sd. H. Vanmeter to his heirs & assigns for ever. Situate on Waters of Mudy [sic] Creek, Washington Co PA in Pursuance of Warrant Dated May 25, 1785 (called Mergilinia) Containing 393 Acres & Allowances Granted to Henry Vanmeter. Patented October 26, 1787 by Henry Vanmeter, Commonwealth the 12th. Enrolled in Patent Book P, Volume 11, Page 317, Novm. 1/1787. (Signed) Benjamin Franklin. Attest, Charles Biddle." [Cornerstone Clues, Vol. XVII, No. 3, Aug. 1992, p. 64-65].

1787 – Grantor index shows that a patent for 393 acres on Muddy Creek, PA Commonwealth to Henry Vanmatre, from 1787, was recorded in Greene Co PA Deeds, Vol. 255, p. 15, on 10 Jan 1917. This suggests that some of the land remained among descendants at least this long.

1787 – Assessment Roll for Cumberland Twp., Washington Co PA, includes Henry Vanmetre, Esqr., with 230 acres land, 5 horses, 13 cows; Joseph Vanmetre, with 200 acres land, 3 horses, 3 cows; Jesse Vanmetre with 200 acres land, 3 horses, 2 cows; and Absalom Vanmetre, single man, 1 horse. The duplicate for sales tax also lists Henry Vanmetre, Esqr., Joseph Vanmetre, Jesse Vanmetre; and Absalom Vanmetre, single man.

1788 – Wolf Scalp, submitted to FamilySearch by Dan Ellingson, 10 Aug 2015 – "Washington County ss, September 14th 1788 – I do hereby certify that Thomas Hughes brought a well grown wolfe [sic] scalp to me & proved according to Law that it was killed in this County therefore do Order the Treasurer to pay the bearer one pound five shillings, by me Henry Vanmetre."

1788 – Cumberland Twp., Washington Co PA Tax List, includes Henry Vanmatre, Esq., 6 horses at .54, 10 cows at .30, and 230 acres of land at 1.15/1.99. Joseph and Jesse Vanmatre are also listed. Note: A transcription in Leckey, p. 135, shows Henry Vanmeter Esquire, Joseph Vanmeter, and Jesse Vanmeter, with Absolom Vanmeter on the single freeman list.

1788 – Henry Vanmeter appears in a list of Commissioners for Washington Co PA under date Nov 1788 [Crumrine, Boyd. *History of Washington Co PA*. Philadelphia PA: H.L. Everts & Co., 1888, p. 469}.

1789 - Indian Massacres [not sure of the source of my photocopy] - "About 1785, William Thomas and his bride, the daughter of Henry Van Meter of Carmichaels, Greene County, moved to the waters of Dunkard Creek on a branch of the creek now known as Miracle Run. They occupied the land which is now the home of Ralph Thomas, in Battelle District, Monongahela County, about two and one-half miles west of Blacksville, West Virginia, near the Mason and Dixon Line. At this time there were no other settlers closer than the town of Blacksville and this part of the country was a wilderness. He took with him a team of horses, a plough, and other farm implements, built a log cabin, and proceeded to clear his land. On April 21, 1789, the Mingo Indians were scouring the country for horses and other loot. George Washington had just been elected the first President of the United States and was about to be sworn into this high office in the city of New York. Late in the afternoon of that day, when William Thomas was working with his horses in a field near the log cabin, a band of roving Indians appeared at the edge of the clearing on the point above the house and fired several shots at him. One or more of the bullets hit him, but he leaped over the bank of a small stream in the edge of the clearing and hid himself in the top of a large fallen tree. There he stuffed leaves into the wound in order to prevent bleeding to death. His wife and infant son were in the cabin at the time. Hearing the shots, she snatched the infant from his cradle and ran to the thicket. That night she made her way to the old fort at Blacksville, where a posse was organized and sent to the scene of the massacre. There they found Thomas' body and buried him in what is now the family cemetery, a few yards from where he died. The posse then trailed the Indians, who had taken the horses with them, and crossed the Ohio River a short distance below Wheeling, where the pursuit ended."

Isaac Young is still there.

Isaac Young is still listed with Henry Vanmatre, Sr. There is yet another list in 1794, labeled Return, with Henry Vanmetre, Sen., with 6 horses, 10 cows, and 230 acres land. Henry, Jr., Joseph, Jesse, and Absalom are listed.







1801 – NOTE: In the will above, Henry Van Matre mentions his land in Kentucky Co VA; however, the State of Kentucky had been admitted to the union on 1 Jun 1792. I think this is a transcription error in the journal for Kanawha Co VA (now WV), and the mention of Isaac Robertson and Francis Watkins in the will correspond to deeds and court actions in Kanawha County. I think the mention of the son "Abraham" is a transcription error for son "Absalom" who is also mentioned in relation to the Kanawha County land. Unfortunately, the estate packet [File No. 55] for Henry Van Matre with the original will, inventory, etc., does not seem to have survived. Hopefully, it was pulled for some later case or by some early genealogist and will still turn up some day.

Indenture, 3 Dec 1802, Henry Vanmatre of Greene Co PA and his wife Martha, to Jesse Vanmatre of same; whereas Henry Vanmatre had obtained a patent called "Mergilina" in Washington now Greene Co for 393 acres, dated 26 Oct 1787, recorded in Patent Book 11, p. 316, he now for consideration of \$2,000, sells to Jesse Vanmatre, land bordering Azariah Davis, Samuel Jackson, Richard Swan, William Kelly, and Morgan Dickenson, being 191 acres. Signed, Henry Vanmatre, Martha her M mark Vanmatre. Witnessed by John Foster and Mary Van Matre; by Thomas Hughes, Esq., JP. Recorded 18 Jan 1803.

1803 – Kanawha Co VA (WV) Court Orders, Vol. 1, p. 177, 14 Jun 1803, Henry Van Meter, 1 wolf scalp, paid \$2.50. Note: Since Henry Vanmeter's will had been probated in February, this is likely his son or grandson. The other Kanawha County suits could be the younger Henry Vanmeters as well.

1803 – Greene Co PA Orphan's Court, Vol. 1, p. 15: "On the Petition of William Thomas, a minor above the age of fourteen years, setting forth that he is by the death of his father and by the Last Will and Testament of Henry Vanmater, deceased, entitled to a considerable real and personal Estate and praying the Court to appoint Martha Vanmater, widow, his grandmother, Guardian of his person and estate. Whereupon the Court appoints Martha Vanmater guardian of the said William Thomas agreeably to the prayer of this Petition." Dated 7 Mar 1803 court; exact copy of appointment of guardian entered 2 Jul 1803.


On the Petition of William Thomas a minor about the age of fourtem years selling forth that he is by the death of his Jather and by the Last Will and Testament of Henry Vanmaler deceased entitled to a considerable real and personal Estate and praying the Court to appoint martha Van mater widow his grand mother Guardian of his person and estate.

Whereupon the Court appoint Martha Van maler quardian of the said William Thomas, agreeably to the prayer of his Petition
Exit Copy of the appointment of quardian 2 July 1803, under Seal.



1803 Kanawha Co VA (WV) Land Tax List, p. 261 – Henry Vanmatre, et al., 1300 acres; Henry Vanmatre, 250 acres; John V Matre [sic], 250 acres.

1803 Kanawha Co VA (WV) Chargeable with Tax, p. 289 – Absolam V Meter [sic], 1 white male over 16, 1 black male over 16, 6 horses; John V Metre, 1 white male over 16, 3 horses; Henry V Metre, 1 white male over 16, 1 horse; Henry V Metre Jr., 1 white male over 16, 1 horse.




1803 – Henry Vanmeter was likely buried in Vanmeter Cemetery, located on his land, now (1972) on the Price farm, one-quarter mile west of the brick house and south of the Red-dog Road, in Jefferson Township near the Cumberland Township line. The volume by Dorothy and James Hennen, p. 649, suggests that "this cemetery has been completely destroyed, most of the stones are said to have been used to line a wall of a spring on the farm. Only one stone could be read at all. Van Matre [not legible], son of Henry Van Matre, died 1792."

1803 – Kanawha Co VA (WV) – County Court 1803, #4 (FHL 8291455, image 19) – Whereas Francis Watkins and wife Nancy by indenture dated 15 Jun 1796 sold 1800 acres in Kanawha Co to Henry V Metre [sic] and Absolam V Metre, and whereas said Nancy Watkins has been unable to travel to court to acknowledge the deed, John Reynolds, Clerk of County Court, has ordered justices to go take her acknowledgement on 13 Apr 1803.

1803 Dec 12 – Petition to the General Assembly of Virginia asking for a division of Kanawha county. Signed by Henry Vanmatre, Henry Vanmatre Junr., Absolem Vanmeeter [sic], and John Vanmatre. Reference: Library of Virginia, Digital Collections, Legislative Petitions, Reel 97, Box 128, Folder 27.



1804 – Kanawha Co VA (WV) – No Vanmeter landowner or taxable in list. The group next appears on the 1805 Mason Co VA (WV) Personal Property Tax List – Henry Vanmetre with 1 male over 16, 6 horses; Hank Vanmetre with 1 male over 16, 1 horse; and John Vanmetre with 1 male over 16, 3 horses. These Kanawha Co VA tax lists are generally Henry Sr of Greene Co PA as the landowner but Henry Jr and Henry 3rd aka "Hank" as the resident taxpayers for the personal property. I therefore won't continue the Mason Co VA tax lists (FHL 1854094) in this article since the subject of this timeline is dead.

1804 – Greene Co PA Deeds, Vol. 2, p. 304, Absalom Vanmatre of Mason Co VA, 8 Jun 1804, 2400 pounds PA currency, to Jesse Vanmatre of Greene Co PA, title to "a certain tract or parcel of land lying in the said County of Greene, formerly the plantation whereon Henry Vanmatre liv'd on and bounded as follows to wit, agoining [sic] Azariah Davis land on the South, James F. Randolph on the West, Daniel Moredock's heirs on the North, and the above Jesse Vanmatre's land whereon he now lives on the East, said tract of land containing two hundred and thirty four acres more or less with its appurtenances, houses, orchards, &c, excepting and reserving for Martha Vanmatre, wife to Henry Vanmatre, disceased [sic], the houses and part of said tract of which Absalom Vanmatre gave the said Martha her natural life by article"; signed, Absalom Vanmatre; witnessed by Franc. Watkins, Richard Swon. On 25 Jan 1808, this was recorded in Common Pleas, by the testimony of Richard Swon and Francis Watkins, to be the act of Absalom Vanmatre, since deceased.

1805 – Greene Co PA Orphan's Court, Docket #1, p. 16 (FHL 861091), under date 2 Sep 1805, Waynesburg, "Charles Swan and Jesse Vanmater, Executor of the last Will and Testament of Henry Vanmater, late of Jefferson Township in Greene County, deceased, appeared and presented their administration account which was passed and the balance of One Hundred and Sixty Dollars and twenty eight cents remaining in their hand ordered to be distributed agreeably to Law."

1815 – Greene Co PA Orphan's Court, Docket #1, p. 57-58, 61, 63-64, concerns the estate of Jesse Vanmetre, deceased. Administrators, Ann Vanmatre and Charles Swan are named on the 3rd Monday of Apr 1815. On 27 Nov 1815, a description of the land is provided with dower issued to the widow Nancy Vanmetre. Noted is "Share No. 2. Thirteen dollars per year during the life of Martha Vanmatre, mother of said Jesse Vanmatre." A petition is given by William Kincade, son-in-law of Jesse Vanmetre of Jefferson Twp., that Jesse died intestate, leaving a widow Nancy, and four children, Jesse, Rachel wife of Jacob Ketcham, Martha wife of Samuel Crago, and Sarah wife of the petitioner. The land is in both Franklin and Jefferson townships and the court orders a partition. On the same court date, 27 Nov 1815, the partition is made with the land divided into four parcels. The same statement concerning Martha is given. On 29 Nov 1815, the land is described with payments of each share to Martha Vanmatre noted – slightly different amounts for each parcel.

1825 – Greene Co PA Orphan's Court, Docket #1, p. 223. On 19 Sep 1825, Charles Swan and Ann Vanmeter, administrators of the estate of Jesse Vanmatre, list the balance of the estate as \$145.12 1/2, and the court orders distribution. This suggests that the mother, Martha Vanmatre, has died, although she is not named in this entry.

The book *Lucas Genealogy*, by Annabelle Kemp (1964) includes Chapter 16 – "Elizabeth Lucas-Moore of Frederick County, Maryland and Descendants" which is a nice treatment of the Henry Vanmeter family

(p. 409-421). Quoting this title: "Martha Moore, dau. of George and Elizabeth Lucas-Moore was b. in Md 1728, mar Henry Van Meter b 1720, d. 1803 in Greene Co Pa. She died 22 yrs later in 1825; both are bur in the family cem on their old farm on the hill above there home in what was originally Van Meter Fort, about 4 miles out of Carmichaels, Pa. Henry Van Meter, Sr., was one of the pioneers who was led by Thomas Gist into the Tenmile Country of Western Pa. This land had been sold by the Indian Trader, John Owens, of Fort Pitt (now Pittsburg), Pa to Abraham Teagarden of Frederick Co Md. And on this land Henry Van Meter and John Swan husband of Elizabeth Lucas, both built their forts on separate branches of a run variously known as Enoch's Run, Swan Run, and now Pumpkin Run. He was in the Tenmile Country as early as 1765 (see Tenmile Country by H. Leckey, p. 32). The Van Meters were all of adventuresome stock with a preference for lands "out beyond." They had preceded Jost Hite into the Shenandoah and then followed him with their families to select sites there while it was still a wilderness, and they were in the forefront of the migration to the Tenmile Country in Pa. Henry Van Meter is said to have been a loyal Virginian as long as there was any hope of having this section become a part of Virginia. He is even cited for having led a band of armed men to prevent the survey party from running the line. This band appeared to be the militia company of Capt. Jesse Pigman, in which two sons of Henry Van Meter, Joseph and Jesse, served as officers which company as late as 1782 refused to furnish the State of Pennsylvania a copy of their muster roll. However after the line had been run and it was no longer a question of ownership of the territory, Henry Van Meter, Sr., became resigned to it and took an active part in the affairs of the community. He became one of the First commissioners of the new Washington Co Pa; served as Associate Judge for a term, then when Greene Co was formed he served as County Treasurer which office he held up until the time of his death in 1803. During the Rev he maintained a fort at his residence on Swan's Run. The old stone house that stood near Henry Van Meter's fort settlement, and which was destroyed by a hurricane a few yrs ago, was in reality the house his son, Jesse Van Meter, built. The home of Henry Van Meter Sr was across the road from this site, about where the house of the Price home stands in 1950. There is no indication that Henry Van Meter Sr lived in any other home. He and his wife are bur on the hill above the house but no markers remain. A copy of the will of Henry Van Meter Sr., was filed for probate in Greene Co Pa 10 Feb 1803 (Will Bk 1, p. 35), but the file on the estate is missing from the box. His wife Martha is named in the will as well as his 13 children and a number of his grandchildren. When Henry Van Meter went to purchase land in Mason Co Va (now W Va) he states in his will that his son Absolom accompanied him as well as Zachariah Vansickles and Anthony Vansickles (the son of Zachariah). Henry Van Meter Sr and his family were members of Goshen Baptist Church which had been erected at Garard's Fort by Jacob Van Meter, believed to have been a brother of Henry Van Meter Sr (see Tenmile Country, p. 33-45)."

I should state my interest in Henry Van Metre. The family Bible of my third great grandfather, John Neel of Cumberland Twp., Greene Co PA (1797-1872) lists his parents as Henry Neel and wife Elizabeth Vanmeter. In the 1980s, I contacted a few Vanmeter researchers, and they did not have a place for my Elizabeth. My hypothesis was that the widow of William Thomas, killed by Indians in 1789, returned to her father Henry Vanmeter's house with her young son, William Thomas, Jr. Vanmeter researchers had no information on her and seemed satisfied with that. My thought was that she remarried to her near neighbor in Cumberland Township, Henry Neel/O'Neal and began having children again in the early 1790s. This might be why Henry Vanmeter provided for his grandson William Thomas separately in this 1801/1803 will – so that Henry Neel/O'Neal wouldn't have the rights as Elizabeth's second husband. No paper record for Elizabeth Neel's Vanmeter maiden name has surfaced other than the aforementioned family Bible notation (and a similar family record for John's sister, Elizabeth Crouch of Washington Co

PA), but autosomal DNA tests give me strong matches to nearly all of Henry Vanmeter's children who left descendants – 135 matches (2023) including William Thomas descendants.

This listing of children comes from a variety of sources, not fully cited here. If there is no tombstone or other accurate family record, I have based approximate birthdates on when they were first taxed and on ages when they had their first child (estimate 20 for father; 18 for mother), rather than the undocumented dates given across the internet, although I used those if I had nothing else. It is interesting that the possible birth order does not correspond well to the order of children listed in the will bequests. We need to locate a family Bible as well as Henry Vanmeter's will packet.

CHILDREN OF HENRY & MARTHA "PATSY" (MOORE) VANMETRE

- 1. Joseph Vanmeter, b. ca. 1747; d. 1808 KY; m. Elizabeth Aiken; Lt in Capt Jesse Pigman's Co of Frontier Rangers 1777 and served in Rev War. The story is that Joseph Vanmeter's body was found on KY side of Ohio River returning from a trip to Indiana in 1808. James Pribble W 3595 mentions mentions Lt. Joseph Vanmeter under Col. William Crawford and Major Thomas Hughes in March 1777 in his Revolutionary War pension application. Jesse Pigman's Revolutionary War pension application R8250 filed 22 Feb 1845 in Union Co IN says that Capt. Joseph Vanmeter had a "spy company" of Virginia men from 1780-81. Both Joseph Vanmeter and Jesse Vanmeter were believed to be in his company. The name Joseph Vanmeter appears as a private under Captain William Crawford on 2 Apr 1781. I will note here that there was a rejected pension application filed by Jacob Vanmeter VA S4804 of Hardin Co KY on 7 Nov 1833 on his father Joseph Vanmeter who had been killed by the Wabash Indians in July 1788 having served with Gen. George Rogers Clark. This is supplemented by Jacob's own application W 8798 and that of Daniel Linder VA S925. This Jacob Vanmeter had served under William Harrod out of Augusta Co VA (now Greene Co PA), however, his father Joseph Vanmeter (killed 1788) could not be our Joseph Vanmeter, since our Joseph was apparently living when Henry Vanmeter wrote his 1801/1803 Greene Co PA will. Joseph and Elizabeth Vanmeter also are in Washington and Greene Co PA deeds and tax lists through 1796. These families were certainly all closely related. Joseph Vanmetre had a patent dated 26 Oct 1787 for Mendosa, 300 acres [Patent Vol. P. No. 11, p. 316], in Washington Co PA, by warrant of 28 May 1785, the same day as Henry Vanmeter in both cases. Joseph Vanmetre had a second patent 6 Jan 1792 for Long Metre, 265 acres, on 20 Feb 1786. It is noted as a Fayette Co warrant, Washington Co patent, but located in what is now Greene County [Patent Vol. P, No. 18, p. 318]. Lucas Genealogy, p. 411-412, "Cyrus Van Meter of Newcastle, Pa., wrote in 1850 that Joseph Van Meter had removed to Indiana, then returned to Pa. on a trip, the horse he was riding came back to Indiana without its rider and when a party looking for him backtracked his route, they found his body on the Kentucky side of the Ohio River. He had either been thrown and killed or had struck a low over-hanging branch, as there was no evidence or signs of any struggle."
- 2. Rachel Vanmeter, b. ca. 1749; d. after father's 1801 will, perhaps in Greene Co PA; m. ca. 1765 (first child 1766) Richard Wiley, s/o David and Mary (Wesley) Wiley, b. ca. 1748; death unknown. I am having difficulty finding any evidence of this family in the records. Some descendants seem to have been in Monongalia Co VA (WV).
- 3. Rebecca Vanmeter, b. ca. 1751; d. ca. 1825 (source unknown) Hardin Co KY; m. ca. 1773 (first child born 1775) Daniel Linder, b. ca. 1749 VA; d. 1840 Hardin Co KY. This couple likely did not migrate to Greene Co PA, or not for long, as Daniel Linder appears at an estate sale in Berkeley

Co VA on 6 Nov 1777. The Linders and Vanmeters lived on Opequon Creek. In 1779, Daniel Linder was among a party on 27 flatboats going down the Ohio River, led by Jacob Van Meter of Greene Co PA, heading to Bear Grass (present Louisville KY) [Ref. Account of Major George Bedinger, noted in Atterbury manuscript – see below}. In 1793, Daniel Lyndon is taxed on 500 acres in Nelson Co KY, and the family was living in Hardin Co KY by 1800. Daniel Linder filed a pension application VA 5925, that he was in Capt. James Patton's Company and spent a short time in the Illinois Country under Gen. George Rogers Clark. Jacob Vanmeter made an affidavit on 7 Nov 1833 that Linder was at the Falls of the Ohio and fought against the Shawnee, served to 1782, and now resides in Hardin Co KY. Daniel Linder also gave an affidavit in 1833 for the pension application of this Jacob Vanmetre W 8798 whose wife was Rebecca Rawlings. Vanmeter had initially served under Capt. William Harrod out of Greene Co PA (then part of Virginia) in 1779. The same Daniel Linder also filed an affidavit in 1833 from Hardin Co KY for Jacob Vanmeter (VA S4804) in his effort (rejected) to seek funds on behalf of his father, Joseph Vanmeter, who was killed by the Wabash Indians in July 1788 while serving under George Rogers Clark in the Illinois country.

- 4. Jesse Vanmeter, b. ca. 1753; died ca. 1814 Greene Co PA (administration 1815 see above); m. ca. 1773 (first child 1775) Nancy Seals, daughter of James and Sarah (Hennessey) O'Neal-Seals; b. 24 Mar 1745 (no source) Harford Co MD; d. 13 May 1827 Circleville, Pickaway Co OH. Nancy m(1) ca. 1815 to Richard Morris of Pickaway Co OH whose first wife, Mary Seals, was Nancy's sister. Richard Morris, s/o Robert & Jacomyntie Morris, was born 14 May 1739 Squanguam, Shrewsbury Twp., Monmouth Co NJ and died 1816 in Circleville, Pickaway Co OH. Jesse Vanmeter erected the stone house near the Cumberland Twp – Jefferson Twp line on the original Henry Vanmeter land in Greene Co PA, identified as the site of Fort Vanmeter. Jesse Vanmetre was a Lt in Capt Joseph Van Meter's Co of Frontier Rangers 1779. Jesse Vanmetre, in company with Azariah Davis, is mentioned in the minutes of Goshen Baptist Church, Whitely Twp., Greene Co PA, in Apr or May 1788, wanting Sister Sarah Hill to come to the next meeting at Muddy Creek concerning her marriage. Jesse had not been attending meetings and declared his non-fellowship on 25 May 1810, the same day that Azariah Davis was re-admitted to Goshen Baptist Church. John Swan, Thomas Hughes, and Jesse Vanmeter are often mentioned in Greene County histories as making the first permanent settlements in this part of the county, John Swan arriving in 1769, and the three constructing Swan and VanMeter's Fort around the Swan cabin as early as 1772.
- 5. Martha Vanmeter, b. 24 Dec 1754 (computed from age on tombstone); d. 24 Oct 1836 Greene Co PA, aged 81 y 10 m, Swan Cem., Cumberland Twp., Greene Co PA; m. 25 Feb 1777 to a cousin, Richard Swan, b. 31 Jan 1752 (computed from tombstone), s/o John and Elizabeth (Lucas) Swan; d. 11 Feb 1822, age 69 y 1 m 11 d; bur. Swan Cem. This family stayed on the home property near Muddy Creek in Cumberland Twp. The first four children are listed in the Swan-Hughes Bible. Probate in Greene Co PA Orphans Court, Vol. 1, p. 179, March Term 1822. In the 1820 Cumberland Twp census, Richard Swan had a male slave, age over 45, and also a free black male, age 14-26.
- 6. Sarah Vanmeter, b. 24 Jun 1758; d. 4 Jul 1825 (tombstone), bur. Swan Cem., Cumberland Twp., Greene Co PA; m. ca. 1773 (first child born 1774) to a cousin, Charles Swan, s/o John and Elizabeth (Lucas) Swan, b. 11 Feb 1756 Frederick Co MD; d. 25 Feb 1832 Carmichaels, Greene Co PA (tombstone); bur. Swan Cem., Cumberland Twp., Greene Co PA. Stayed in Cumberland Twp

- building a cabin in 1772 near Muddy Creek. Oath of allegiance 1777 (age 21) given by Henry Vanmeter (see above). The surname is often spelled "Swon" in early records. Birthdates from a family Bible exist for all thirteen children. Charles Swan served in the 5th Battalion, Washington Co Militia under Capt. William Crawford and Lt. Col. Thomas Crooke during the Revolutionary War. In the 1820 Cumberland Twp. census, Charles Swan had two slaves, a female over 45 and a male 26-45. His son-in-law, James Seaton, owned a male slave, age 26-45.
- 7. Phoebe Vanmeter, b. 8 Jul 1760 (source not known); d. 14 Feb 1853 Wayne Twp., Wayne Co IN; m. 28 Jul 1778 (unknown source and perhaps not correct as first child not born until 1789) Fayette Co PA to Ellis Thomas, son of Ellis and Elizabeth (Zane) Thomas, Sr., b. 20 Oct 1753 Bucks Co PA; d. 25 Sep 1832 Grave Creek, Tyler Co VA (WV). Ellis Thomas Sr supposedly moved to Ohio Co VA and later to Tyler Co VA. He and his wife are in the 1830 Tyler Co VA census, both age 70-79; he is on the personal property taxes in Tyler Co for 1830 but not 1831-1832. An Ellis Thomas is listed with Revolutionary War service in Capt. Gobin's Militia in Berkeley Co VA with a William Thomas. Although the distance from Greene County is great, this was one of the ancestral homes of the Vanmetre family. The widow Phoebe Thomas lived in 1840 Wayne Twp., Wayne Co IN, age 60-69, and also in 1850, Phoebe Thomas 80 VA, with children Nancy 53 PA and William 42 VA. She is not found in the 1853 death records for Tyler Co VA, and the death location of Grave Creek noted on many websites is probably incorrect. The son, William Thomas, a merchant in Richmond, Wayne Twp., Wayne Co IN, likely brought his mother to Indiana in her old age. William Thomas married late in life, 23 Feb 1856, and had two children born in Wayne County. More work is needed on this family since the age is off for Phoebe in later census years.
- 8. Elsie (called Alice in the transcribed will of father) Vanmeter, b. ca. 1762; d. ca. 1799 Jefferson Twp., Greene Co PA; bur. Garrard's Fort Cemetery, Greene Co PA; m. ca. 1780 (1st child in 1781) Washington Co PA to Azariah Davis, s/o William and Elizabeth (Wollison) Davis, b. 12 Feb 1756 likely in Charlestown Twp., Chester Co PA; d. 22 Sep 1839 Morgan Twp., Knox Co OH; bur. Sixth Street Cemetery, Section 57, Newark, Licking Co OH. He m(2) ca. 1800 Cumberland Twp., Greene Co PA to Mary Harrington Smith, b. 13 Sep 1774 Greene Co PA, d/o Benjamin Smith; d. 19 Sep 1836 near Utica in Morgan Twp., Knox Co OH; bur. Sixth Street Cemetery, Section 11, Newark, Licking Co OH. Azariah Davis served in the Revolutionary War as an Ensign1781 in the 2nd Company, 4th Battalion, Washington Co PA Militia, and was commissioned as a Lieutenant on 1 May 1783 in the 2nd Company, 3rd Battalion, Washington Co PA Militia under Henry Enoch. He also was at the battle of Point Pleasant (Mason Co VA/WV) serving in William Harrod's Company. Azariah Davis was a grantor of land in Jefferson Twp., Greene Co PA in 1801 called "Long Metre", a tract he got from his father-in-law, Henry Van Metre. Note: Davis family members were being buried in Union Grove Cemetery, Harrison Twp., Knox Co OH in the 1830s. This monument in Newark is just a list of Revolutionary War soldiers put up by the DAR in 1976. I'm not sure if they had strong evidence that Azariah Davis was buried there. Azariah Daves [sic] was received by baptism 8 Sep 1785 in the Goshen Baptist Church, Garrard's Fort, Whitley Twp., Greene Co PA, that had been organized by Jacob Vanmetre, likely a brother of Henry Vanmetre. Although a deacon, Davis was excluded from the church on 24 Feb 1798 for "honeration." He was restored by letter 25 May 1810.
- 9. Absalom Vanmeter, b. ca. 1765 (single freeman or at least age 21 in 1786; first appears on tax rolls in 1789 single man); d. ca. 1805 Mason Co VA; m. 13 Apr 1790 (source not known; first child 1792) Redstone, Fayette Co PA to his cousin, Priscilla Van Meter; lived in Mason Co VA. Jun

- 1804 Kanawha Co VA deed for Absalom. Mason Co VA Fee Book, v. 2, p. 17, shows John McCulloch & Francis Watkins, administration of estate, and record of appointment for Absalom Vanmetre, deceased, fees paid in 1805; also v. 3, p. 25 (1808). Not sure of parentage of Priscilla Van Meter and have no dates for her. She is on a 1799 Kanawha Co VA deed but not on the Greene Co PA 1804 deed where Absalom provides for his mother, Martha; however, his wife Priscilla may not have been entitled to the Henry Vanmeter Sr land. 1786 Septennial Census, Washington Co PA, includes Absolom Vanmatre, single freeman. 1790 Census, Washington Co PA, p. 162, husband/wife, no children.
- 10. Elizabeth Vanmeter, b. ca. 1767; d. after 1820 Cumberland Twp., Greene Co PA census; m. ca. 1786 to William Thomas, who was killed by Indians on 21 Apr 1789 on Miracle Run near Blackville, Monongalia Co VA (WV) just south of Greene Co PA state line, "age unknown" on tombstone; bur. Thomas Cemetery, Monongalia Co WV. She m(2) ca. 1791 Cumberland Twp., Greene Co PA (first child born 1792) to Henry Neel/O'Neel, son of Barnet and Mary O'Neel, b. ca. 1770 Greene Co PA; d. after 1821 Cumberland Twp enumeration. Henry and Elizabeth Neel sold Henry's share of the O'Neel patent land in 1806 (Greene Co PA Deeds, v. 2B, p. 203-204) and their lot in Carmichaels in 1818 (Greene Co PA Deeds, v. 4, p. 76) and I don't know if they died or moved elsewhere. Their children started showing up as heads of household in the 1830 Cumberland Twp., Greene Co PA census. Henry Neel/O'Neel was a blacksmith and was taxed for a still.
- 11. John Vanmeter, b. ca. 1769 (first on tax rolls in 1798); d. 2 Jun 1846 (source unknown) Mason Co VA (WV); m. ca. 1790 (first child 1792) likely in Washington Co PA (both parents in census) to Amelia "Mille" or "Milly" Kelly, daughter of Robert and Margaret (Crawford) Kelly, b. ca. 1773; d. 13 Nov 1841 (source unknown) Mason Co VA. John Vanmeter was a veteran of the War of 1812 in Capt. Anthony Van Sickles' Mason County Rifleman who helped construct Fort Meigs in northern Ohio. Age 50-60 (John) in 1830 census Mason Co VA, p. 166 don't spot in 1840; spot no probate.
- 12. Mary Vanmeter, b. ca. 1771; d. 1810/1811 Mason Co VA shortly after 28 Dec 1810 birth of son Eli Van Sickles; m. 29 Apr 1789 Redstone, Fayette Co PA (cannot find source; first child born 1792) to Capt. Anthony B. Van Sickles, b. 13 Sep 1760, son of Zachariah and Rosanna (Buckley) Van Sickles (elsewhere Samuel Van Sickles); d. 29 Sep 1815 Mason Co VA; bur. Doctor Jesse Bennett Cemetery, Point Pleasant, Mason Co VA. Enlisted in War of 1812 at Point Pleasant, Mason Co VA in Gen. Leftridge's Brigade, Col. Dudley Evans' 2nd Regiment Virginia Militia; Captain of Van Sickle's Mason County Riflemen. They joined the Shawnee and Wyandot near Delaware OH and then marched to Fort Meigs on 1 Feb 1813 where they finished construction of the fort (now Perrysburg OH). He m(2) 6 Jun 1811 Gallia Co OH by Rev. Eli Stedman (v. 1, p. 22) to Zelpha Hubble, b. 10 Oct 1788 MA; d. 21 Nov 1857 Meigs Co OH. She m(2) 27 Dec 1818 Gallia Co OH by Aaron Hatch (v. 1, p. 81) to Rev. Elihu "Eli" Stedman for his second wife, b. 17 Aug 1777 Tunbridge, Orange Co VT; d. 29 May 1845 Rutland Twp., Meigs Co OH; tombstone in Miles Cem., Rutland, Meigs Co OH. "Deed" index for Mason Co VA shows will for Anthony Van Sickles and estate in Vol. AA, p. 71, 75, 92; and further estate mentioning Zelpha Van Sickles in Vol. AA, p. 74, but wills/estates online seem to start in 1829 and do not include this early "AA" volume in either probate or deed records. The Vanmeter genealogies list "Mary" as the Van Sickles wife, but some Van Sickles genealogies list "Rebecca" as the wife. I cannot find any deeds

- of sale to show a wife's name. Anthony Van Sickles seems to have held on to his land until his death shortly after his War of 1812 service.
- 13. Henry Vanmeter, b. ca. 13 Jun 1773 Cumberland Twp., Greene Co PA (first on tax rolls in 1794); d. 13 Dec 1857 of old age in Fairview, Mason Co VA, age 84 y 6 m; death record (v. 1, p. 43-44) identifies him as son of Henry & Patsy Vanmeter; m(1) ca. 1793 (first child born 1794) to Christina Van Sickles, d/o Zachariah and Rosanna (Buckley) Van Sickles (others say Samuel Van Sickles), b. ca. 1775 Morris Co NJ; d. 1814 (possibly inferred from date of second marriage); m(2) 24 Oct 1815 Mason Co VA (WV) to Elizabeth "Betsy" Peck, d/o Peter & Mary (Green) Peck, b. ca. 1783 VA (1850 census); d. after 1850 (Henry & Elizabeth are living with separate relatives in 1850 Mason Co VA census) and likely before 1853 when death records start in Mason Co VA (WV).

END NOTE

We need to keep an open mind when exploring the early life and ancestry of our Henry Vanmeter. There were certainly multiple Henry Vanmeters. Our man is likely a brother of Jacob and Abraham. The Shepherd family and Hedges family (with Vanmeter wives) were also in Greene Co PA. It is possible that our Henry Vanmeter had a first wife. Historians have given three wives to the Henry Vanmeter in the published genealogical records who they identify as the son of John. It may be more complicated. We might mark Henry Vanmeter as being born by at least 1727, dying in 1803, with his wife Martha, born ca. 1729, and dying ca. 1825 — unless she was a younger second wife. Her extreme age was unusual for that time period, and that almost suggests an earlier wife. Martha could have been a much younger person and not the mother of the older children. The family needs a resorting from the many clues out there, and we need to make sure that our ancestor Henry Vanmeter gets a rightful place in the larger Vanmeter family tree.
